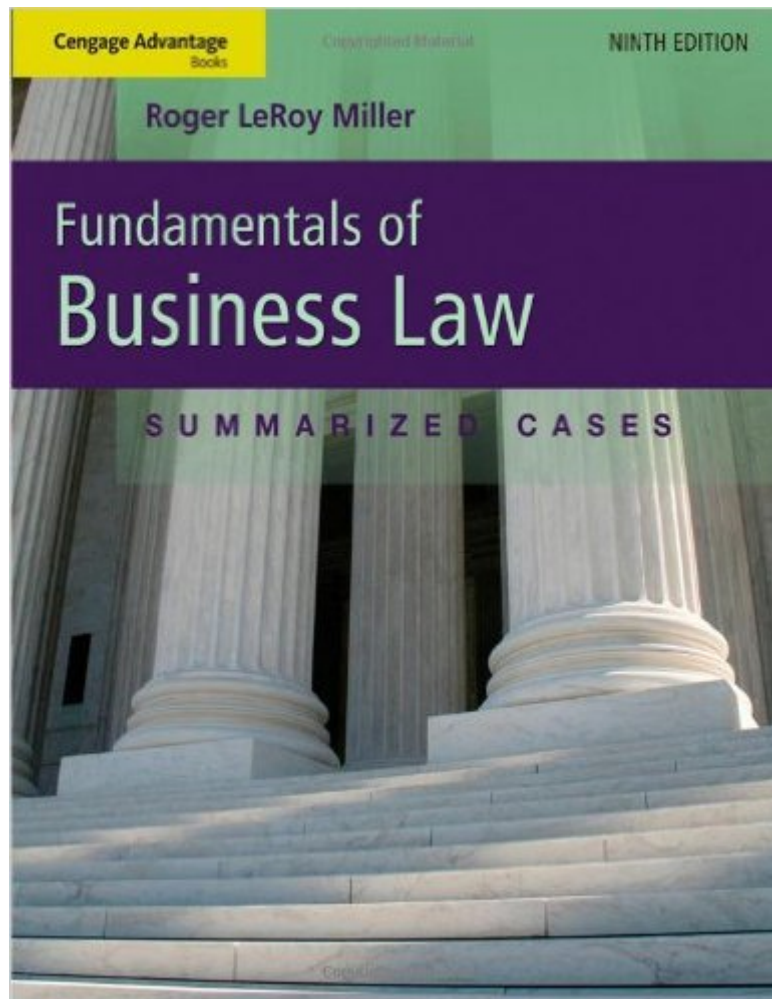

Although I am not planning to be a lawyer, I definitely learned a lot and have found that I am already utilizing some of the information I retained throughout the course. The book is straightforward and an easy read. It's not the most exciting book, but then again, I don't think many law books are. This is one of the best textbooks I've ever studied from. I don't think there's a single wasted word or sentence. Each concept is well laid out without unnecessary repetition usually found in textbooks.
